Penalty for delaying transmittal of assessment moneys is provided in ORS 576.355, which states, "In addition to the penalties prescribed in ORS 576.991, any person who delays transmittal of funds beyond the time set by a commission shall pay a penalty of 10 percent of the amount due and shall pay one and one-half percent interest per month on the unpaid balance of assessment."
